REVISED NOTICE

In view of the **India AI Impact Summit Delhi 2026** being organized at Bharat Mandapam from 16th February, 2026 to 20th February, 2026, to be presided by the Hon'ble Prime Minister of India, the date of Bar Council of Delhi Election, which was earlier fixed for 20th to 22nd February, 2026, has been staggered further as there will be huge requirement of police forces, traffic arrangements for VVIP movements, and the same will coincide with one of the election dates, i.e. 20th February, 2026, of the Bar Council of Delhi fixed earlier and will cause administrative problems, both for the traffic as well as the police and securities.
