**ADVISORY FOR REMOVAL OF HOARDINGS,  
BANNERS, POSTERS, ETC.**

Ld. Advocates,

It has been observed with concern that certain prospective candidates for the forthcoming elections to the Bar Council of Delhi have started engaging in activity/ies that are prejudicial to the decorum and dignity of the legal profession. Such act/s bring disrepute to the noble profession of Advocates, apart from infracting laid down norms, rules and extant provisions governing the field.

In particular, it has come to notice that hoardings, banners, posters and similar promotional materials have been erected or affixed at various public and private places, defacing property and causing public inconvenience. Such acts are rampant and inconsistent with the high standards of conduct expected from members of the legal fraternity. The Bar Council, can, under no circumstance permit this.

The Bar Council of Delhi hereby cautions all prospective candidates against indulging in any such unwarranted, unethical, or unbecoming activities that tend to bring disrepute to the legal profession.

It is hereby made clear that any such acts, as referred to above or relatable thereto or connected therewith, shall be viewed seriously. The Special Committee of the Bar Council of Delhi has noted with dismay and anguish, such unbecoming conduct. Any person/s found engaging in such like activity/ies shall be liable for disciplinary proceedings, which may include but shall not be limited to disqualification from candidature in the forthcoming elections to the Bar Council of Delhi.




